• Faculty on <u>fiscal</u> year contracts must be appointed on or before the beginning of <u>spring</u> semester for that year to count towards year in rank.

Prior Credit - Must be awarded/approved by the Provost on initial appointment. Use of prior credit years by the candidate is optional.

- If 3 Yrs Prior Credit Awarded Can receive preliminary consideration in spring at end of first year of initial appointment.
- If 2 Yrs Prior Credit Awarded Can receive preliminary consideration in spring at end of second year of initial appointment.
- If 1 Yr Prior Credit Awarded Can receive preliminary consideration in spring at end of third year of initial appointment.
